

PREAMBLE AND RESOLUTIONS.

WHEREAS, It pleased Almighty God, on the 17th inst., to take from our midst NATHANIEL GRANT, one of the Incorporators of the Church Charity Association, and one of the original Directors and Trustees of "All Saints' Hospital," and at the time of his death the Vice-President; therefore,

Resolved, That we, the surviving Directors, do hereby place on record our esteem for our departed Brother and our deep sense of the loss his death has caused. His earnest interest in the Hospital, his energetic labors, watchful care and wise counsels rendered him an invaluable member of our Board. We desire also to express our opinion of him as a man: one of high honor, strict probity, firm and unflinching adherence to principle, who has won the deepest respect and esteem of all with whom he was associated. The Directors of "All Saints' Hospital" extend their deepest sympathy to the wife and family of our departed member.

Resolved, That the Directors room in the Hospital be draped in mourning for thirty days.

DIRECTORS REPORT.

THE Directors of All Saints' Hospital present to the public their Second Annual Report. And they rejoice to be able to report an increase in the efficiency, usefulness and prosperity of the Hospital. The number of patients admitted during the year was 317, making an increase of 111 over the number received the year previous. There were remaining in the Hospital at the close of the previous year 15, making the total number treated during this year 332. The total receipts for the year were \$7,974.77 and total expenditures, including interest, repairs, payment of back debts, \$7,871.77. Through careful management and the liberality of a few friends, we have been able not only to pay all the expenses of the past year, but also to discharge all unpaid bills of the previous year, some of which had been incurred at the very beginning of the work.

It is a great satisfaction to feel now that every dollar we receive for current expenses can be devoted to the present efficiency of the Hospital—save only that which must be paid for interest on our funded debt. And the question now remains, cannot this funded debt be discharged, so that every dollar that comes in may be directly applied to the care of the sick? The Directors have been informed that there is one who is ready to contribute sufficient for the payment of half this debt if the other half can be raised. Who will help us in this matter? The debt is \$5,000. The \$400 paid annually in interest would maintain 35 or 40 free patients.

The death rate of the Hospital has been remarkably low—20 cases out of 317. The Doctors, Sister and nurses have met with remarkable success in bringing safely through many cases that seemed hopeless—especially cases of typhoid fever, and some very severe surgical cases.

The seeming increase of expense of treatment over that of last year is owing, not to an actual increase, but to the fact that at the close of last year there were many outstanding bills un-

paid, which ought to have been reckoned in the expense of last year and were not, and have since been paid and counted as of this year's expenses.

The general aspect of the internal work remains the same as last reported—the patients have all been well contented, and many of them warm in their expressions of satisfaction with the care and attention they have received. Our patients, as in the previous year, have been in numbers, first, residents of Kansas City, a certain number of travelers—taken sick on the road or while passing through, and a large number from the Far West. These latter, mostly surgical cases, who come in three, four and five hundred miles for treatment, add great interest to the work, and show the importance of a Hospital at this point. The following is an instance: An old man living 400 miles out in Kansas, was blind from cataracts. He was told that if he could get to Kansas City he might have his sight restored. So with \$20 in his pocket, and his two children to lead him (a boy and girl about 10 and 12 years of age) he started to walk. He traveled on foot 240 miles, when he arrived in a town where he had a brother-in-law, who loaned him a farm-wagon loaded with enough hay to keep the horses three weeks. When he arrived in this city he paid all the money he had left for a shed for his horses. His plan was that the children should sleep in the wagon and he come to the Hospital. Some good woman heard of the children and took them in and gave them food and lodging. We knew nothing of this until his stay having been delayed beyond three weeks, he insisted he must go because the horses had no food, and thus we came to know the story of his journey. The horses were provided for, the man's sight restored, and he was sent away with means to provide for himself and children on the way; and he reached home in safety. Not many come to us in this way, but many come as far, finding in Kansas City with its Hospitals the nearest relief that skillful surgery can give.

There was started last February a Society called "The Aid of the Society of All Saints' Hospital," consisting of members of the

Church Charity Association. Its objects are to solicit and collect subscriptions for the support of the Hospital, to visit the sick in the Hospital, and, where desirable, after they leave the Hospital, and to provide flowers, fruits and delicacies for the sick. This Society has, so far, collected about \$200, and a committee have kept up a regular visiting of the Hospital.

The Rector of St. Mary's Church visits the Hospital almost daily, ready to minister to all who desire spiritual ministrations. He has baptized in the past year six adults and one infant and administered the Holy Communion to seven persons *in extremis* and to several others. The ministers of all denominations are always welcomed in the Hospital, and where patients desire it they are sent for.

The Directors tender their hearty thanks to all who have aided them in their work in the past year, and beg that their former friends will continue their liberality, and they sincerely hope that new names may be added to the list. It is to be regretted that the report for this year does not show a greater increase in voluntary contributions. The amount for 1885-6 was \$1,141.01; that for 1886-7 was \$1,488.44—an increase of only \$347.43. It is to be hoped that a second year's proof of the efficiency and usefulness of this work may win for it a more liberal recognition on the part of those disposed to support works of charity.

The Hospital lost a valuable friend and worker in the death of its Vice-President, Col. Nathaniel Grant.
