THE Directors of All Saints' Hospital present to the public the Sixth Annual Report of the good work under their charge. The number of patients admitted is not so large as in the two previous years, which may be in part owing to the shrinkage in population, especially among the class who are most apt to find need for hospitals, and also to the improved sanitary condition of the city. That this latter fact in a measure accounts for the smaller number of patients may be gathered from the fact that the diminution is among the medical rather than the surgical cases.

Our Treasurer's Report shows that there is due him the sum of \$1,401.16, being the amount he has advanced to pay bills. Part of it is the amount of \$559.75 advanced last year and remaining unpaid, leaving \$841.41 to represent the deficiency this year. This hospital is not receiving the support from the public which it deserves. We never have been able to do the work we might do, for want of funds, and now contributions have fallen off so greatly that we will not be able to continue the work even on the scale of the past six years unless some good friends come forward and relieve us from our present embarrassment. During the six years of its existence 1,977 patients have been received within its walls. Of these 1,857 have been discharged recovered or improved. The death rate for the six years has been 16 in 100. This fact is sufficient to show the efficiency of the work. Fourteen per cent of the cases have been treated without any remuneration, 10 per cent for \$5 per week, and the balance have received for \$10 a week what would cost \$30 a week outside of a hospital. We can rightly apply the title of charity to all our work. How many there are of moderate incomes who can afford to pay the small expense of a hospital charge for some weeks sickness, but would not otherwise procure the attendance of trained nurses and other care which they receive in the rooms of such an institution.

The experience of our six years has shown that we need, in addition to the pay of patients, voluntary contributions of

about \$200 per month, to enable us to treat such charity cases as come to us. To do away with charity work altogether would be foreign to the purpose for which the hospital was founded. In truth, we ought to have much more than the above named sum given to us, that we might enlarge the amount of charitable work. Who will help us? Gifts large or small will be most welcome. Such gifts go to the treatment of purely charitable cases. Our report shows that the number of days of treatment was over 29 per cent of the whole. The amount of money expended over and above the pay of patients was less than 25 per cent of the whole; so every cent given to us and every cent advanced by the Treasurer, as well as some of the money paid by patients, has been used for treatment of charity cases.
